County official admitted 911 calls went up after Renton Red Lion hotel converted to a Homeless Hotel.

The county and City are rushing to closing the deal in a few days without fully listening the input and addressing the concerns from the neighboring communities.

We, people of King county, demand transparency and clarity of any projects impacting our community before the decision is made. This site should not be purchased and converted without public input.

2. Effective security and Accountability for the safety of the children, staff in schools, and local families.


